Warnings

Truck Bed and Camper Protection

Torklift **does not** recommend installing your camper on top of a plastic bed liner (or other compressible material such as foam). These materials can act as a spring, causing increased vertical truck camper movement independent of the vehicle. Plastic bed liners can slide on the truck bed surface, and the truck camper can slide on top of the bed liner. Using a plastic bed liner or similar compressible material will void your warranty and may additionally cause truck bed and/or camper damage.





Minor movement or settling can occur in some incidental harsh driving conditions (on or off-road). A rubber bed mat is recommended to protect the truck bed and camper, but is not a requirement to maintain the Torklift legendary lifetime warranty.










Suspension

To significantly reduce body roll, sag and sway Torklift strongly recommends the StableLoad. Torklift International StableLoads improve safety, handling, and to help level your truck. More information can be found at (www.Torklift.com/stableload).

If your truck is additionally equipped with suspension air bags Torklift cautions against over pressurization as this may lead to unsafe vehicle handling characteristics. We have found that airbags used in conjunction with StableLoads have allowed operators to lower air bag pressure by 50% or more. Only pressurize suspension air bags enough to level the truck.

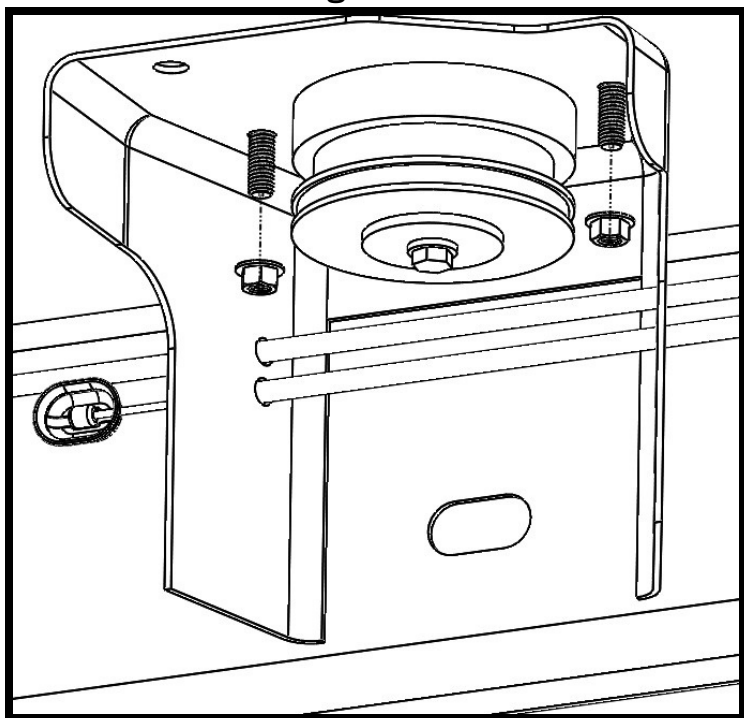

Step 1:

Begin by Removing the two factory nuts located at the top of the cab mounting bracket on the driver side. Keep the factory nuts, they will be reinstalled later See Figure 1.1

Step 2:

Remove the parking brake cable. Mark or count how many threads are exposed before loosening. Loosen the cable adjustment screw until the nut is completely backed off. See Figure 2.1 & 2.2. Remove the cable from the coupler shown in Figure 2.3. To release the cable, push forward and remove from bracket. See figure 2.3

Remove the main cable from the parking brake. To remove the cable, start by using a screwdriver to pry open one of the two tabs on the coupler, then push forward to release. Remove cables from the vehicle mounting location to allow better access to the frame. See figure 2.4 & 2.5 & 2.6.

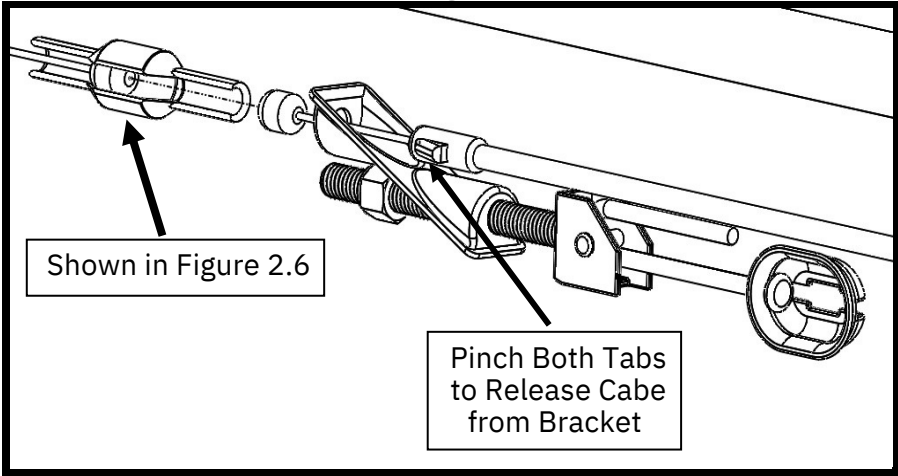
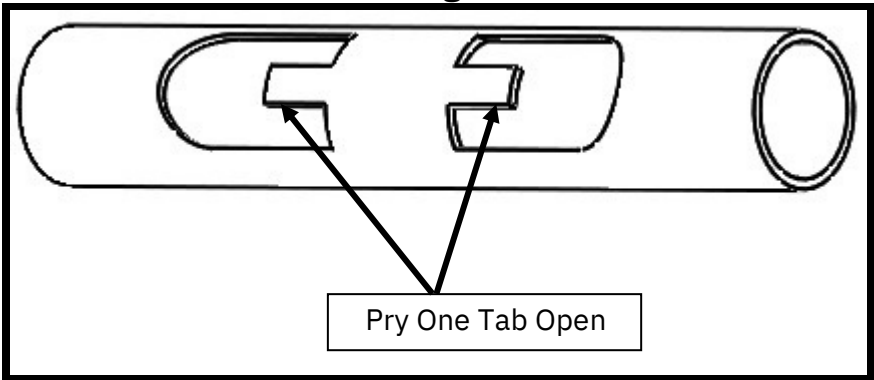

Step 3:

Attach a ½" x 2" bolt to the bolt fisher, star washer and plate washer. Insert the hardware into the frame and leave bolt fisher attached. See Figure 3.1.

Step 4:

Fish the tail end of the bolt fisher through the middle tie down hole. Raise the tie down into place while pulling the bolt fisher through. Align the two holes on the tie down with studs in frame. Reinstall the factory nuts removed on Step 1: Torque to 25ft-lbs See Figure 4.1 & 4.2.

Step 5:

Carefully remove the bolt fisher and install one ½" flat washer, lock washer, and nut. Leave hardware loose. See figure 5.1.

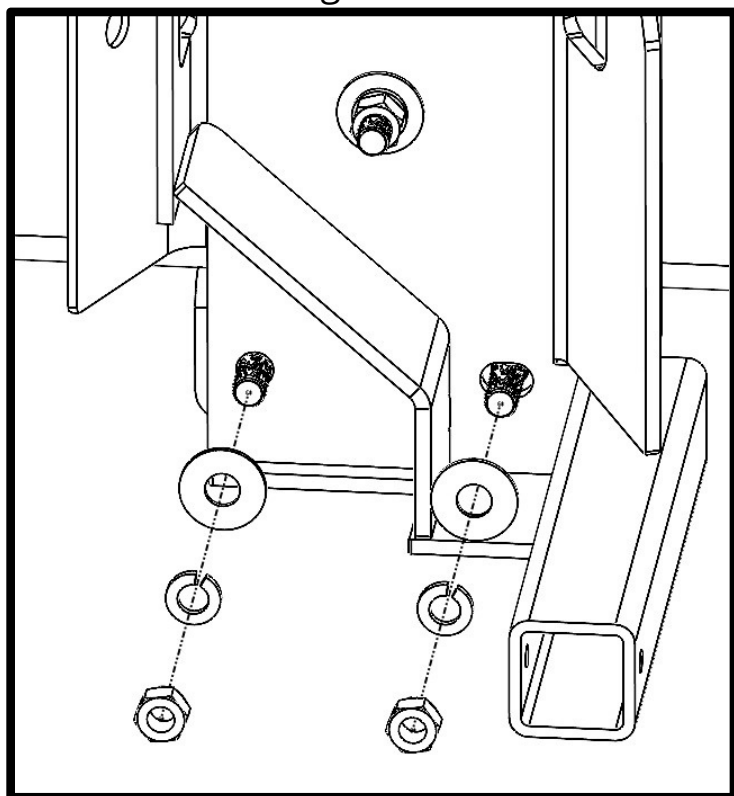
Step 6:

Install the tie down clamp from the inside of the frame. Insert two 1/2" x 1-3/4" bolts, flat washers through the clamp with the bolts facing outward. Secure the clamp using a flat washer, lock washer and a nut. Torque all 1/2" hardware to 75ft-lbs. See Figure 6.1 & 6.2.

Step 7:

Reinstall the parking brake cable in the reverse order of removal. Refer to previous steps. Install the parking brake tensioner nut in approximately where it was before removal. Test Emergency brake for proper operation, adjust the nut if necessary. Repeat steps 1,3,5 & 6 on the passenger side.

Step 8: Install Tie Down Inserts

Insert one of the tie down inserts into each tie down receiver.

Pin the inserts in place with a 2-1/4" bail pin. Either hole in the insert can be used. We recommend at least 1" (25mm) of clearance between the body and turnbuckles when setup.

Place a front insert sticker onto the face of each insert. See Figure 8.1.

IMPORTANT NOTE: Your tie down inserts are designed to have clearance inside of the receiver. This is to account for road debris, as well as aid in installation and removal. Some rattle may be expected if the inserts are left installed while not under load from the camper.
